#### **Privacy Protection**

Protecting your privacy, along with your confidential business records, is of primary importance to us as it relates to your satisfaction with our service. We can only succeed if you are fully satisfied. You have chosen to use our service, and we recognize our obligation to keep the information you provide to us secure and confidential. Our commitment to protect your information will continue under the principles and online guidelines described below.

## **Information Security**

## **Information Sharing**

We limit who receives information and what type of information is shared among authorized employees of AC Electric Vehicles. We do not share information with outside companies, such as marketing or advertising firms or credit bureaus. AC Electric Vehicles is committed to making sure that your Online Transactions are safe and secure. With our own security infrastructure in place, we are confident that access to your accounts is private and secure. While AC Electric Vehicles works to protect your privacy, you also play a role in protecting your accounts. Only provide your Access ID or Online ID when your browser shows a Secure Socket Layer (SSL) connection directly to the provider or to another site you have investigated and fully trust. No AC Electric Vehicles employee will ever ask you for your password. Information may be exchanged when legally required based on court orders ONLY. If we receive a subpoena or similar legal process demanding release of any information about you, we will generally attempt to notify you (unless we believe we are prohibited from doing so). Except as required by law or as described above, we do not share information with other parties, including government agencies.

#### **Privacy Online**

Whenever we ask for personal information on our Web Site, we use Secure Socket Layer (SSL technology) for transferring data. This technology encrypts — or scrambles — your account information, so it's virtually impossible for anyone other than AV Electric Vehicles to read it.
